








Submitters by ward




Submitters by method




Submitters by ratepayer



Submitters by age




Submitters by urban / rural

Do you agree with our proposed limits on rates and debt, including our proposal to potentially exceed our 4% limit on rates increases for three years of the 10 year plan?



Overall comment

Rates increases and the proposal to potentially exceed our 4% limit in three years of the 10 year plan. We've set a limit on overall annual rate increases at 4%. That 4% includes forecast inflation (at an average of 2.13%), which is outside of our control. We believe that this 4% limit strikes a balance between affordability, while also meeting the demands of things like increasing environmental standards, a growing population, people's expectations and the pressures that tourism puts on our infrastructure. We've also identified that we don't want to stand still – we'd like to do more for our district. But, if we're going to deliver all the improvements we're proposing, we may exceed our 4% limit on rates for three of the 10 years. On average, rates increases would still be below 4% over the 10 years.

To avoid exceeding the 4% limit, we could smooth the rate increases over the 10 years, so that we plan to collect the same total amount in rates, but collect them later – effectively a buy now, pay later arrangement, that would enable the rate increases to remain within what we believe is an affordable level from year to year.

Alternatively we could reduce our overall expenditure to avoid exceeding the limit. For example we could reduce services; like mowing the parks less often, we could not make improvements or defer capital work to our facilities, and we could increase fees such as pool entry. No single example would keep the forecast rate increases below 4% in all 10 years of the Long Term Plan, but might change what year we exceed the limit, or mean we only exceed it in one or two years, instead of three.



Economic Opportunities

Do you agree with our plans to increase support for economic development in our community?



Overall comment

Employing an economic resource - We plan to employ someone to facilitate economic development in our district for at least the next three years. This person would be responsible for supporting economic growth in our district. This does not have an effect on rates or debt as it is funded through existing budgets.

Investing in regional development - We plan to invest an additional \$30,000 in a regional economic development agency to support a regional economic development strategy. Council could decide not to invest in a regional development agency which would have an impact on rates however it may also mean that we have to develop an economic development strategy on our own rather than Waikato wide which may in turn have a larger impact on rates in the long term.

Increasing funding to Morrinsville Chamber of Commerce by \$5,000, and Matamata Public Relations Association by \$15,000 to \$75,000 each. Council called for submissions in August/September 2017 from all groups who have previously received grants from Council through a Long Term Plan or Annual Plan. Council held a hearing and made decisions on these submissions in October 2017 which have been incorporated into the Long Term Plan budgets.

We have currently budgeted 1.75 million for the revitalisation of our three main towns in the first three years of the Plan. \$750,000 for Matamata in 19/20 and \$500,000 each for Morrinsville and Te Aroha in 20/21.



Do you agree with our plans to increase support for youth and community groups and work closer with Iwi?



Overall comment

Funding for youth - We recognise the importance of hearing the views of younger people in our district to understand issues that impact them. We are proposing to provide \$10,000 each year of new funding to support the Matamata-Piako Volunteer Youth Ambassadors. Council is hoping to work in partnership with other agencies to obtain other funding for youth events.

Increases to grants - We support a wide range of groups in the community through grants to help achieve a variety of outcomes for the district. The funding recipients are listed in the Long Term Plan, including the contestable funds and the increases we are proposing to these budgets. Council called for submissions in August/September 2017 from all groups who have previously received grants from Council through a Long Term Plan or Annual Plan. Council held a hearing and made decisions on these submissions in October 2017 which have been incorporated into the Long Term Plan budgets.


Working with Iwi - We are planning to work with individual Iwi to develop relationship agreements on how we will engage with each other. These will sit alongside Treaty of Waitangi Settlement agreements and other committees that Council administers or participates in. This will be funded through existing budgets and will have no impact on rates.

Do you think we've made the right choices for the bypasses?



Overall comment

Matamata bypass - this would link Waharoa Road East and Tauranga Road and is anticipated to significantly reduce traffic (including heavy vehicles) through Matamata's CBD. It is estimated to cost around \$30 million to build. We plan to fund feasibility studies and purchase land for the Matamata bypass in the next 10 years, with funding for the construction included in the Infrastructure Strategy, but not until 2031 (outside the timeframe of this Long Term Plan). Bypasses can have both positive and negative effects for small towns, the positive effects are largely around removing heavy traffic from main streets however the negative effects are largely around businesses potentially losing out on business of passersby who may ordinarily stop and have something to eat or do some shopping

Council has currently budgeted:

- \$150,000 to undertake a further need analysis and feasibility studies.
- \$1.85 million for the design and the extension of the designation.
- \$1.1 million for the net purchase of land.

Council could remove the bypass designation however this would potentially mean that we would remove the option of having a bypass at any stage in the future. Leaving the bypass designation in place means we can review the construction of the bypass if the Waikato Expressway from Hamilton to Piarere (expected to be completed in 2024) alleviates pressure on Matamata's roads.

Morrinsville bypass - this would link Kuranui Road to the intersection between Roache Road and State Highway 26. It is estimated to cost in excess of \$40 million to build, which would need to be funded by Council through loans and paid for through rates. We plan to remove the designation and allocated funding for land purchase for the Morrinsville bypass purchase from the Long Term Plan and Development Contributions Policy. This would remove the possibility of a town bypass for Morrinsville in the future. Council could budget to extend the designation (\$4.5 million in total) within the next 10 years, and budget for construction within the next 30 years. Assuming the land purchase, feasibility study and design were completed by 2027, this would increase rates by 1% by 2028, and increase debt by \$4.5 million, but still within our debt limit. This however would not take into account the construction of the bypass, this would need to be budgeted for within the next 30 years.



Environmental Sustainability overall comment

Transfer station fees - We plan to increase the fees at the transfer stations to recover an additional \$100,000 from this service (currently subsidised by rates). Increasing the fees will help cover more of the costs of the facilities, and encourage people to reduce their waste. The service is currently being subsidised by the general rate and the increase to the fees proposed represent a fair increase to cover actual costs. There are concerns that increasing the fees for general waste could increase illegal dumping on roadsides, Council could consider putting in implementation strategies to deal with this if it occurs. Council could also consider reducing fees for green waste if desired to encourage people to dispose of green waste appropriately.

Rubbish bag changes - selling rubbish bags through retailers and at Council offices for \$2 per bag, instead of through targeted rates. Targeted rates will go down significantly (from \$153 to around \$30). This means if you only buy 52 rubbish bags (the same number you were previously allocated), you will be paying less overall for rubbish and recycling services.

In 2017 Council reviewed and consulted the community on the joint Eastern Waikato Waste Management and Minimisation Plan (WMMP) in conjunction with Hauraki and Thames-Coromandel District Councils which sets out clear targets to reduce waste to landfill. In response to this, during June-July last year Council carried out consultation called 'Love your district reduce your waste' which sought feedback on ten initiatives to reduce waste going to landfill. One of these initiatives was about changing to a rubbish bag system that gives people an incentive to reduce their waste. Of the 87 submissions we received, 34 supported this initiative, 33 did not support and 20 did not state a position. 39 submitters felt this change was very important/important, 12 considered it somewhat important or not so important and 36 did not specify. Council considered this feedback at its meeting on 11 October 2017 and decided to shift to the new rubbish bag system to provide an incentive to waste minimisation.

A small portion of rubbish costs is being added into general rates e.g. rubbish in CBDs and parks because everyone benefits and therefore should pay a small portion.


We plan to develop a business case for a joint waste minimisation position within the Eastern Waikato (Matamata-Piako, Thames-Coromandel and Hauraki District Councils). The focus of this role would be to develop and implement a waste minimisation programme and engaging the community on initiatives that have been successful in minimising waste.

We have budgeted \$1.8million to improve services at our three transfer stations, \$600,000 per facility, one per year for the first three years of the plan.

Healthy Communities overall comment

Focusing on the little things – we have budgeted an additional \$320,000 to make improvements to the look and feel of a whole range of things in our communities.

Cycleway extension - The trail currently links Te Aroha to Paeroa, with an extension from Te Aroha to Matamata planned to open in 2019. We're proposing to develop side trails from the new trail to points of interest such as Wairere Falls and Waiorongomai. Once these sections have been completed we plan to extend the cycleway from Matamata through Hinuera and to Piarere, to link up with the Waikato River Trail and Te Awa Cycleway (which currently runs from Hamilton to Taupo).

We are proposing to:

- Provide funding of \$750,000 over three years from general rates to develop side trails to the existing trail.
- Provide part funding of \$1.5 million for the extension through to Piarere. This section would not be built unless external funding can be secured for the balance of the cost.

In Councils infrastructure Strategy funding has been planned for the extension of the cycleway to Morrinsville in 2030/31 with an estimated cost of \$3million and land currently owned by KiwiRail could potentially be used for parts of the trail.

Headon stadium - is Council's only indoor sports facility in Matamata. It has one court and was built in 1974. We are currently planning some major repair and renewal work for the stadium in 2018/19, But this does not include any major upgrade or expansion of the current facility. We have budgeted to proceed with the major renewals and maintenance works to Headon Stadium (up to \$1.5 million) in 2018/19.


New sports stadium - The 2009 Community Leisure Provision Strategy identified that Matamata could potentially support an additional facility. However, we believe a comprehensive feasibility study should be completed first. The Regional Sports Facility Plan 2014 did not identify a sub-regional need for a new sports facility in Matamata but recommended that we optimise existing assets before we invest in new ones. We have budgeted a further \$2 million in 2019/20 to either expand Headon Stadium or contribute to building a new indoor facility in Matamata (depending on the results of the feasibility study).

Other projects we have budgeted for include:

- Continuing with extensions to our walkways, \$1.9million
- Expanding the Te Aroha Cemetery in 2018/19, \$550,000
- Reviewing our corporate property in 2018/19, \$450,000
- Adding splashparks to our pool facilities in 2020/21, \$210,000
- Replacing the Waharoa public toilets in 2019/20, \$200,000
- Improving the Domain in 2020/21, \$500,000

Currently, the closest all-weather athletics track is 45 minutes away. For any serious athlete or coach, this is too far to travel 4 or more times per week, year round. The benefits of an all-weather athletics track in Matamata include:</p> <ul style="list-style-type: none"> • Year-round usage in all weathers • A first-grade facility for local athletics clubs thereby leading to increased number of participants in athletics • Participants of other sports will use it for conditioning • The general public will use it for keeping fit • Attraction of national and regional competitions (often held over three or more days) will bring large number of visitors, thereby benefitting Matamata businesses • A large facility for a relatively low cost (due to it mostly being outdoors) Other sports could use the centre field for events <p>I have travelled the world as an athletics coach and seen many athletics facilities. I would suggest the following stages for an athletics facility in Matamata:</p> <ul style="list-style-type: none"> • Stage 1: Install a 6-lane, outdoor track (rather than an 8 or 9 lane track). 6-lane tracks are very common in Europe and are much less expensive. The track could be designed so an additional two or three lanes could be added later if needed. • Stage 2: Add a small stand for spectators, a photo finish room, and storerooms. • Stage 3: When funding permits, add an 8-lane 150m indoor straight track alongside the outdoor track. This 'set-up' is reasonably common in Europe, and would provide an indoor facility during winter, and also a warm-up area for when major championships are held at the outdoor track. • An alternative plan would be to start with stage 3 first.

Setting lower disposal fees at waste management sites and higher fines for illegal dumping Environmental authorities together with the local governments need to set lower disposal fees to encourage people to use the lawfully stipulated waste disposal systems. At the same time, the relevant regulatory bodies against illegal dumping must set higher fines to discourage the habit. This can be done by re-defining the fines and punishments for illegal dumping as well as the licensing and charge rates acts for dumping services. For instance, it has been cited that in some areas it may be less costly to illegally dump and pay a fine than using the rightful waste disposal channels. By employing this strategy, societies can become less vulnerable to illegal dumping. End of quote. <p>I believe we need to look at ways to improve waste minimisation, education and making it easier to get rid of non-recyclable waste. Also I would class the change of selling rubbish bags through retailers, instead being funded by rates and being distributed to all households owned or rented, as a similar factor in providing a key for illegal rubbish dumping by those who choose not to purchase bags due to economic pressures within their household environment. I think it important to clarify that the neighbouring properties to the unkempt berms sighted throughout Te Aroha are in most instances tidily kept. The berms are not part of these properties and in many instances significantly large and on a difficult gradient It would be fair to say that as a council you are aware of the cost of mowing these berms hence the council decision to abandon this community responsibility. I have not spoken with all property neighbours of unkempt berms but on the occasion I have had contact with the neighbouring dwelling occupants they have voiced an inability to manage these berms physically, time wise or financially. And they despair at the impact of this situation for them within their home/community. This brings me to the concerning proposal of a reduction of mowing and/or grounds management of community parks and common grounds in Te Aroha. Te Aroha parks currently provide a community facility that avails itself to all residents and is well utilised by our community as a whole alongside the many tourists that our area draws and benefits from. To reduce the upkeep of our parks will quite obviously risk the triggering catalyst for a reduction in the culture of park use, possibly even dropping parts of them to the already established 'hovel' status of some areas of our community post the council berm maintenance change. It is a frequently noted starting point of communities desiring to improve utilisation and safety of park users, to establish restoration plans of the community park environs. Therefore I see it as an extraordinary and negligent proposal to reduce the basic maintenance of our parks and risk this outcome. Thinking about our major towns, the following come to mind:</p> <ul style="list-style-type: none"> - Te Aroha – hot pools, walking, cycling, mountain biking, Edwardian architecture, Kaimais proximity - Morrinsville – dairying, quirky cows, Jacinda, walking tracks - Matamata – horses & dairying, Hobbiton, Wairere Falls <p>Not a lot compared to say the Coromandel or the Bay of Plenty with their coast lines, but enough to form a base. I see the region's key opportunities for economic development being centered on environmental tourism and the outdoors, perhaps supplemented by history, dairying, art & culture. The cycle trail from Paeroa to Te Aroha has already proved itself, and its extension to Matamata and on (with a spur to Hobbiton) to Piarere is absolutely crucial. Having a continuous safe linkage from the Cambridge cycle trails through Matamata and Te Aroha to Paeroa will see a steady stream of outdoors-focused tourists looking for points of interest, activities, cafes/restaurants and accommodation. Outdoor activities based on tramping and mountain biking (Te Aroha and Te Miro trails) could be a particular focus. It may also be worthwhile to attract and promote one big event that puts one of our towns on the map (Paeroa's Battle of the Streets motorcycle race comes to mind as an example).</p> <p>Vibrant Cultural Values Funding for youth and iwi is important, and ties in nicely with the increased economic opportunities that come from expanding environmental tourism.</p> <p>Connected Infrastructure Bypasses are a double-edged sword as they have the potential to deprive retailers on the main street of passing custom, however they remove heavy traffic and make the town centre a much more attractive place for people.
