Waharoa Substation

Matamata-Piako District Council has received notice of a requirement for a designation from **Powerco Limited**.

The requirement is for:

The designation is for the purpose of operating an electricity substation. There is an existing electricity substation on the subject site. No changes to the existing substation are proposed for the foreseeable future. However, should further growth in the Matamata-Piako District result in increased demand for power requiring the substation to be altered or upgraded, then future works may be necessary.

The site to which the requirement applies is as follows:

The property is legally described as Lot 3 DP 333824, located at 3 Dunlop Road, Waharoa. The site is located on the north-western side of the intersection of Hawes Street and Dunlop Road in the industrial area of Waharoa.
