We are starting to review the planning rules for Papakāinga and need your input. Papakāinga is a collective and traditional form of Māori living, it translates to "a nurturing place to return to".

This plan change would set guidelines for Māori to live communally with extended whānau on their ancestral land. This could include multiple homes, educational facilities, communal areas, as well as supporting home and rural businesses. Development of papakāinga would unlock ancestral land – creating opportunities for whanau to return and connect. It would also provide opportunities for tamariki to live on ancestral land – closer to their grandparents, aunts and uncles, developing a deeper connection with ancestors laid to rest on the papakāinga.

What is the purpose of this plan change?

The Plan Change seeks to include new rules that enable quality papakainga development that supports the social, cultural and economic wellbeing of tangata whenua.

There are two key aspects of the plan change. First, is the introduction of a Maori Purpose Zone (MPZ), the second is Papakainga District Wide Provisions in the rural zone.


