

Kia ora Alana

I hope everything is well with you.

I am assisting Warwick and Marion Steffert (the Applicant) in relation to a Private Plan Change application to rezone 13.4ha of land in Morrinsville from Rural Zone to General Industrial Zone (see location map below). The Plan Change involves changes to the Matamata-Piako District Plan.

The site is located on the western edge of Morrinsville and is immediately adjacent to existing Industrial zoned land. The rezoning will go some way to addressing a medium-term to long-term shortfall of industrial land in Morrinsville which has recently been identified by Matamata-Piako District Council (MPDC) in a report that the Council commissioned in accordance with the National Policy Statement on Urban Development.



We are currently preparing the Plan Change application and anticipate lodging it with MPDC in late November or early December. As part of its preparation, we have been consulting Ngati Haua Iwi Trust over the past several months through Norm Hill. Norm has prepared a Cultural Values Assessment (CVA) which the Trust has recently signed off on and which will be submitted as part of the Plan Change request. The CVA is attached.

The recommendations in the CVA relate to cultural protocols associated with construction works (blessing and accidental discovery protocols), the incorporation of cultural narrative as part of place-making (including reflection of cultural values through landscape design), cultural street and reserve naming, Local Government planning for infrastructure upgrades, stormwater management, contributions to the restoration of the Morrinsville Stream and the Ngati Haua Iwi Trust and the Applicant continuing to work together in good faith.

Recommendation 8 is that contributions to the restoration of the Morrinsville Stream be undertaken. The Applicant supports this recommendation in principle; however, the stream is located outside of the PC58 Site within private landholdings. The Applicant would be willing to support future opportunities for coordinated restoration should they arise, potentially involving other landowners, Councils and mana whenua. The Plan Change application will address this and will confirm that the Applicant is otherwise comfortable with the recommendations, some of which will be addressed as part of future stages of consenting and development.

We would appreciate hearing from you as to whether Waikato-Tainui has any views on the proposed rezoning. Please let me know if you require any additional information or if you would like to meet to discuss the Plan Change proposal.
