My submission is:

As a Trustee of Kai-a-te-mata Marae, and a Trustee of a Maungatapu D4 whānau freehold Māori land, I support the planned changes to the provisions put forward in both Precinct 1 & 2.

These changes will allow kaumātua and kuia the opportunity to live near our Marae, where they are often needed to support marae kaupapa that happen regularly. This is particularly important to maintain our level of tikanga and manaaki tangata. Our whānau are grateful too for the opportunity to put some of our own whenua to use for a papakainga. In this way our whānau are able to either house our aging whānau members, especially those who have rented all their lives and/or offer opportunities for our younger generation to put a home on the whenua and come home to work the land. For so long the system has favoured single land ownership entities negating much of Māori shared whenua usage. Our view of whenua is that 'we do not OWN the whenua', we belong to the whenua. It nurtures us, it sustains us as a collective. Allowing us to return to how we made use of whenua before the land laws changed things for Māori, can once again allow the people to put into the whenua and look after it so it continues to sustain our whānau in perpetuity, both figuratively and practically.

Having whānau returning to live on whenua that will once again be operated by whānau is the ultimate aspiration.
