This settlement does not need to be built in the paddock surrounding our home. Our outlook is the Kaimai Range, the reason we bought the property was to have a rural setting and Kaimai views. Our other outlook is a state highway that has become so busy with logging trucks, trucks and general traffic, we seriously need a beautiful setting to the rear of our property for our mental health and our child's welfare.

Our driveway is located on a busy, blind corner of Tauranga Road. If this is your proposed entrance to multiple houses then that would make a very dangerous situation. The driveway is shared with us and the paddock where you propose building this settlement. It would cause extensive traffic, dust and extra pollution driving directly past our home.

If this was to go ahead, do you think it's fair to give one ethnicity the right to build multiple homes on their private land but not on others?
