INTRODUCTION

HEARING PROTOCOL

- 3. Lay submitters may present their statements on the day of the hearing.
- 4. To assist with an efficient hearing process, the Hearing Panel make the following s.41C RMA directions:
 - (a) Following the opening, the Council as the plan change proponent may present a short overview (no more than 20 minutes) noting the scope and nature of the plan change and the key issues for consideration. The requirements noted in paragraph 2 above will apply.
 - (b) The Hearing Panel will then invite submitters / persons in the order as noted in the attached schedule, to present their submission statements and answer any questions the Hearing Panel may have.
 - (c) The Hearing Panel is not aware of any other submitters seeking to be heard other than those listed on the hearing schedule – but if they are wishing to be heard, they should make themselves known to Ms Kaumoana prior to the commencement of the hearing so that a place can be assigned to them to present their statement.
 - (d) After all submitters have been heard, the Council's reporting officer will be invited to address and respond to any specific issues raised by submitters or the Hearing Panel. For clarity, this is not an opportunity to introduce any new evidence.
 - (e) The Panel will then adjourn the hearing.
