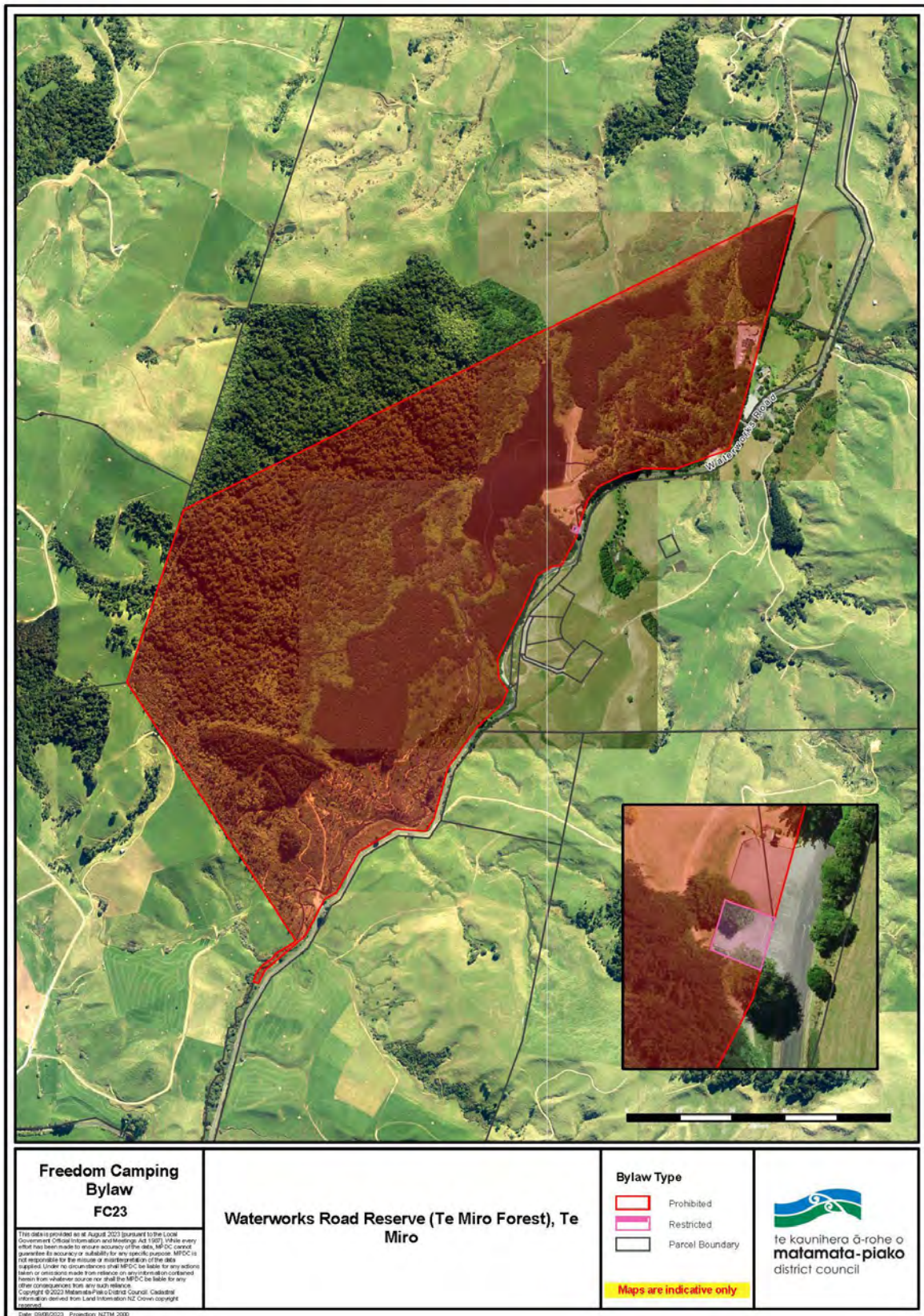






Areas where freedom camping is restricted - Morrinsville Ward

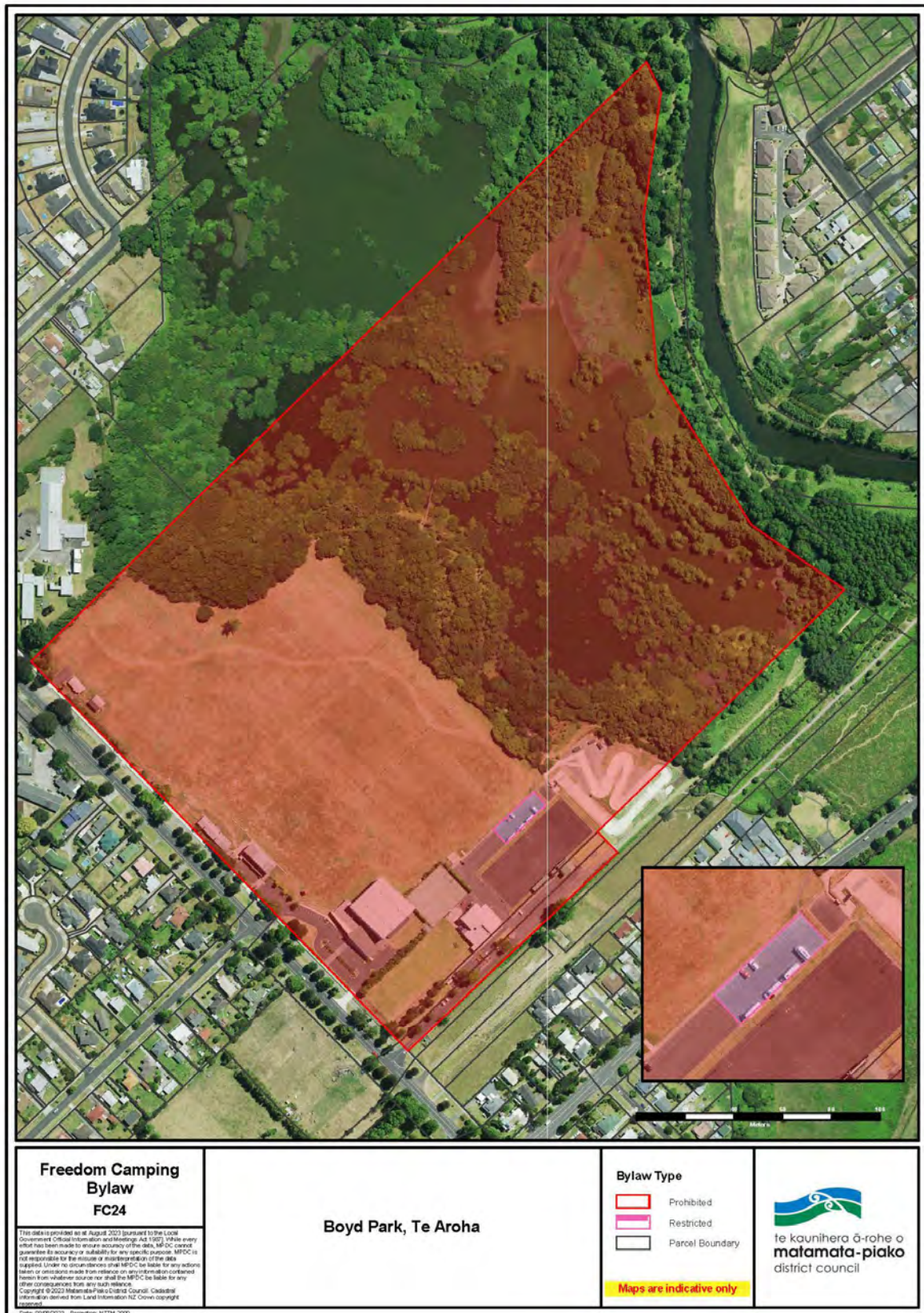
