a) Alcohol may only be sold under this licence on the following days and hours:

- b) A manager, holding a current Manager's Certificate issued pursuant to the Sale and Supply of Alcohol Act 2012 shall be responsible for the sale of alcohol during these events.
- c) The licensee shall have a reasonable range of food available for consumption on the premises at all times when alcohol may be sold under the licence. The food shall be of the range and types of food submitted with the application but must be no less substantial than snack foods in the nature of pies, sandwiches, filled rolls, pizza or the like. The availability of these foodstuffs shall be notified to patrons by appropriate notices throughout the premises.
- d) The licensee shall have a reasonable range of low alcohol and non-alcoholic refreshments available for consumption on the premises at all times when alcohol may be sold under the licence.
- e) The licensee shall ensure that drinking water will be made readily available to all attendees, free of charge.
- f) There are no designations.
- g) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:

Message

Council on the 11 February 2015 resolve to delegate the Group Manager Community Development and the District Planner the ability to reduce the fee by one class in accordance with Section 10(2) of the Regulations.

Through this resolution the following guidance was given in regards to applications where this delegation might be used:

It is envisaged that a fee reduction will only be agreed to on very rare occasions. Events where a fee reduction may be considered appropriate include:

- *Events where the total anticipated patronage of an overarching event may be disproportional to the likely patronage of a stall selling alcohol within that event.*
- *Events run by charities where the primary purpose of the event is to enable charitable organisations or individuals to run events with the potential to contribute in a positive way toward community outcomes and the community as a whole.*

It is my opinion that the above special licence meets this guidance and I therefore authorise a fee reduction from a class one to a class two for the following events:
